ORDER

This day this cause came on for hearing after numerous conferences, hearings and discussions had with representatives of the oil and gas industry and others for the purpose of considering the adoption by this Board of an order amending the special field rules heretofore adopted for various gas fields in the state hereinafter named so as to delete from said special field rules all provisions with reference to and/or governing the allocation of gas and setting of gas allowables in said fields; and

WHEREAS, pursuant to such conferences, hearings and discussions, and order of this Board duly entered, due, proper and legal notice of the hearing of this cause was given in the manner and within the time provided by law and the rules and regulations of this Board, and due, legal and sufficient proofs of publication are on file with the Board and the Board has full jurisdiction of the subject matter to hear and determine this matter; and

WHEREAS, pursuant to said notice given, public hearings were held by said Board in the Second Floor Auditorium of the Woolfolk State Office Building, Jackson, Mississippi, commencing on December 21, 1977, and subsequent thereto, including a hearing held on this date, May 17, 1978, at all of which hearings all persons who desired to be heard on said matter were heard and all testimony and evidence were duly considered by those present at said meetings; and

WHEREAS, the Board has now fully considered said matter and the evidence and recommendations made in said hearings and is now fully advised in the premises; and

WHEREAS, the Board finds that simultaneously herewith the Board has this date adopted its Order No. 182-78 amending Statewide Rule 34 to include in said rule provisions governing the allocation of gas from non-associated gas pools in the state and the setting of gas allowances on a semi-annual basis, and other pertinent provisions, and that special field rules heretofore adopted for various gas fields in the state hereinafter named should be amended so as to delete from said field rules those portions governing the allocation of gas which are in conflict with the statewide rules this date adopted by the Board effective as of July 1, 1978;

NOW, THEREFORE, IT IS HEREBY ORDERED by the State Oil and Gas Board that gas allocation provisions contained in the special field rules heretofore adopted for those gas fields in the state set out below, to the extent that such field rules are in conflict with the statewide rule above referred to this date adopted, be and the same are hereby repealed, said fields including but not limited to the following:

Aberdeen Field, Baxterville Field, Beans Ferry Field, Carthage Point Field, Cranfield Field, Dexter Field, Fayette Field, Gwinville Field, Hub Field, Knoxo Field, Maxie Field, Muldon Field, Pistol Ridge Field, West Pistol Ridge Field, Sandy Hook Field, Sharon Field, Soso Field, Stewart Field, and Waveland Field.

This order shall take effect and be in force from and after July 1, 1978.

SO ORDERED, on this the 17th day of May, 1978.
