## ORDER

This day this cause came on for hearing before the State Oil and Gas Board on the matter of the adoption and promulgation by the Board of Special Field Rules for the Moss Hill Field in Adams County, Mississippi, said hearing being called for such purpose upon the petition of Douglas Whitaker and J. K. Wright; and

The Board finding that due, proper and legal notice of the meeting of the Board for the purpose of considering and taking action with respect to said matter has been given in the manner and way as provided by law and the rules and regulations of the Board and that due, legal and sufficient proofs of publication are on file with the Board and that the Board has full jurisdiction of the subject matter to hear and determine same; and

WHEREAS, pursuant to said notice given, a public hearing was held by said Board in the Second Floor Auditorium of the Woolfolk Office Building at Jackson, Mississippi, on September 17, 1958, at which time and place all persons present who desired to be heard on said matters were heard and all proposed Special Field Rules were fully discussed and duly considered by those present at said meeting; and

WHEREAS, the Board has fully considered said matter and the evidence and recommendations made in said hearing and is of the opinion that the following Special Field Rules should be adopted for the prevention of waste and the protection of the correlative rights of all owners in said field;

IT IS, THEREFORE, HEREBY ORDERED by the State Oil and Gas
Board that the following Special Field Rules be and the same are hereby
adopted by the State Oil and Gas Board of Mississippi for the Moss Hill
Field located in Adams County, Mississippi, to take effect on and after October 1, 1958, to-wit:

## SPECIAL FIELD RULES FOR MOSS HILL FIELD IN ADAMS COUNTY, MISSISSIPPI

- A. The Moss Hill Field, as used herein, is that area in Sections 33 and 34, Township 6 North, Range 2 West, Adams County, Mississippi underlain by the Luce Pool and the Whittington Pool, as defined hereafter, and all productive extensions thereof.
- B. The separate and distinct pools from which production is being obtained in Moss Hill Field are defined as follows, to-wit:
  - (1) The Luce Pool as used herein shall be construed to mean those strata of the Wilcox Formation productive of oil from the depths of 5316' to 5360' in the Douglas Whitaker J. K. Wright, Whittington Heirs Well No. 1 in Section 33, Township 6 North, Range 2 West, Adams County, Mississippi, and including those strata productive of oil which can be correlated with this horizon.
  - (2) The Whittington Pool as used herein shall be construed to mean those strata of the Wilcox Formation productive of oil from the depths of 5410' to 5490' in the Douglas Whitaker J. K. Wright, Whittington Heirs Well No. 1 located in Section 33, Township 6 North, Range 2 West, Adams County, Mississippi, and including those strata productive of oil which can be correlated with this horizon.
- C. The characteristics of the producing pools are such, and the evidence shows, that one well drilled on each forty (40) acre drilling unit will efficiently drain and produce the recoverable oil from subject unit and said pools without avoidable waste.
- D. All rules and regulations contained in State Wide Order No. 201-51 and amendments thereto are recognized as fully applicable to the two separate

pools in said Moss Hill Field, and said rules are hereby adopted and shall apply to the two pools in said Field.

Said rules to be in full force and effect on and after October 1, 1958, reserving, however, unto all parties the full benefit and protection of any rights accruing to said parties which may have become vested by law in such parties, prior to the adoption of said rules.
