ORDER NO. 372-86ORDER ESTABLISHING SPECIAL FIELD RULES

THIS MATTER came on for hearing on the Petition of Radzewicz Operating Corporation, seeking to establish Special Field Rules for the Stanton Field, Adams County, Mississippi, and the Board being fully advised, does find as follows:

1.

Proper, due and legal notice for the meeting of this Board to consider this Petition has been given as required by law and the rules of this Board, and due, legal and sufficient proofs of publication of notice are on file with this Board. The Board does further adjudicate that it has full and complete jurisdiction of the subject matter to hear and determine this Petition at this time and place.

2.

Radzewicz Operating Corporation is the operator of the Proby No. 1-A in Stanton Field, and is of the opinion that Special Field Rules should be established for this field. The proposed Special Field Rules are attached hereto as Exhibit "A". As noted in the Special Field Rules, Radzewicz Operating Corporation recommended that the field be developed on spacing pattern as provided in Statewide Rules.

3.

In the Special Field Rules, Radzewicz Operating

Corporation proposed to define the following pools:

The First Wilcox Sand Gas Pool shall be construed to mean those strata productive of gas in the interval between 3,962 feet to 3,974 feet as recorded on the Dual Induction-SFL-Sonic Log for the Radzewicz Operating Corporation, Proby No. 1-A Well and all sands correlative of these strata productive of gas, said well being located at a point described as: From the southeast corner of Section 35, Township 8 North, Range 2 West, go 1,832 feet along the North line of Section 50; thence northeast at right angles, 1,347 feet to the location, Section 41, Township 8 North, Range 1 West, Adams County, Mississippi.

The Sparta Sand Gas Pool shall be construed to mean those strata productive of gas in the interval between 2,974 feet to 2,982 feet as recorded on the Dual Induction-SFL-Sonic Log for the Radzewicz Operating Corporation, Proby No. 1-A Well and all sands correlative of these strata productive of gas, said well being located at a point described as: From the southeast corner of Section 35, Township 8 North, Range 2 West, go 1,832 feet along the North line of Section 50; thence northeast at right angles, 1,347 feet to the location, Section 41, Township 8 North, Range 1 West, Adams County, Mississippi.

4.

If the proposed Special Field Rules are adopted, the development of the above pools will be promoted, waste will be prevented and the coequal and correlative rights of all parties will be protected. It is the opinion of this Board that the proposed Special Field Rules be adopted.

IT IS, THEREFORE, ORDERED AND ADJUDGED that Special Field Rules for the Stanton Field in Adams County,

Mississippi, be and they are hereby established as above set forth.

EXHIBIT "A"

SPECIAL FIELD RULES FOR THE STANTON FIELD

A. The Stanton Field as used herein is that area consisting of the following described land as underlain by the First Wilcox Sand Gas Pool and the Sparta Gas Pool and all productive extensions thereof:

ADAMS COUNTY, MISSISSIPPI

Beginning at the corner common to Sections 35 and 50, (southeast corner of Section 35), T8N-R2W, Adams County, Mississippi, being the most westerly corner of within described tract.

Thence from said point of beginning go north-easterly along the east line of Section 35, T8N-R2W and Section 43, T8N-R1W, for 3,517 feet, more or less, to Fairchilds Creek; thence in a general southeasterly direction along Fairchilds Creek for 5,000 feet, more or less; thence S 37°00' W for 3,860 feet, more or less, to the center of a bayou, being boundary between Proby and McGehee property; thence in a westerly direction along the center of said bayou for 440 feet, more or less; thence continue along said boundary between Proby and McGehee the following courses and distances:

N 47° 43' W for 1995 feet, more or less,
N 45° 25' W for 313.7 feet,
N 57° 57' W for 245.6 feet,
N 77° 58' W for 134.2 feet, and
S 87° 35' W for 924.0 feet
to the point of beginning

Said within described tract contains 320.0 acres.

B. The First Wilcox Gas Sand Pool shall be construed to mean those strata productive of gas in the interval between 3,962 feet to 3,974 feet as recorded on the Dual Induction-SFL-Sonic Log for the Radzewicz Operating Corporation, Proby No. 1-A Well and all sands correlative of these strata productive of gas, said well being located at a point described as: From the southeast corner of

Section 35, Township 8 North, Range 2 West, go 1,832 feet along the North line of Section 50; thence northeast at right angles, 1,347 feet to the location, Section 41, Township 8 North, Range 1 West, Adams County, Mississippi.

C. The Sparta Sand Gas Pool shall be construed to mean those strata productive of gas in the interval between 2,974 feet to 2,982 feet as recorded on the Dual Induction-SFL-Sonic Log for the Radzewicz Operating Corporation, Proby No. 1-A Well and all sands correlative of these strata productive of gas, said well being located at a point described as: From the southeast corner of Section 35, Township 8 North, Range 2 West, go 1,832 feet along the North line of Section 50; thence northeast at right angles, 1,347 feet to the location, Section 41, Township 8 North, Range 1 West, Adams County, Mississippi.

RULE 1 - SPACING OF GAS WELLS:

Spacing for gas wells in the Stanton Field shall be that spacing provided in Statewide Rule 8.

APPLICABILITY OF STATEWIDE RULES:

A. All rules and regulations contained in Statewide Order No. 201-52, and any amendments thereto not specifically covered in the foregoing Special Field Rules are hereby adopted and shall apply to said field.

B. The Board expressly reserves the right, after notice and hearing, to alter, amend or repeal any and all of the foregoing rules and regulations.
